They can also teach undergraduate medical students the part of pathology related to the orofacial region. A step taken in this direction will indirectly benefit both the branches.

Oral pathologists can also be helpful in the diagnosis and maintenance of cancer registries especially dealing with oral cancer and oral potentially malignant disorders under the pathology department of medical colleges and hospitals.

Also, they can be a part of various tobacco eradication/de-addiction programs started by the government at various levels. Oral pathologists are well versed with oral signs and symptoms of tobacco use and thus, can help the patient in tobacco cessation at the earliest.

As this is a burning topic in our specialty, we all should make an effort to discuss and come out with some solutions to rejuvenate the branch of oral pathology. The above suggestions, if appropriate, can be discussed among the seniors and at different platforms such as national and international conferences.

As it is rightly said the path is difficult, but a small step can make a difference. A journey of a thousand miles begins with a single step!!
